On page three, you will find step-by-step, detailed instructions to guide you through the Online Registration. Your child(ren) will be officially enrolled when the registration process is complete and approved. If classes are full, your child may be placed on a waiting list. You will receive a notice by email from the Registrar once you are accepted.

Checklist of Procedures for NEW FAMILY Registration

___ **1. Read the LAM FAMILY HANDBOOK June 2019 - May 2020** and keep it for future reference. We prefer that you read this before scheduling your Interview/Tour with the Principal or Assistant Principal. (The HANDBOOK is available on the LAM website, under the Registration tab and at the LAM Office.)

___ **2. Schedule your Parent Interview/Tour** with the Principal or Assistant Principal by calling the LAM Office (208) 765-8238.

___ **3. Complete your Online Registration.** **Please use a laptop or desktop with a Windows Operating System and Chrome as your browser when completing the Online Application.* Those using a cellphone or Apple/Mac Operating Systems have not been successful! We have a laptop available for your use at the LAM Office.

Go to the LAM website, www.lamcda.org. On the left side of the screen, click on the **2019-20 NEW FAMILY REGISTRATION** link. Use the step-by-step, detailed instructions on page three (3) to guide you through the Online Registration.

___ **3a.** If registering more than one student, return to the LAM website, www.lamcda.org. On the left side of the screen, click on the **2019-20 SIBLING REGISTRATION FOR NEW FAMILIES** link. Repeat for each additional student.

___ **4. Return the following items to the LAM Office** beginning Tuesday, March 12, 2019 at 8:30 am:

___ **Registration Fees** (Non-Refundable)

___ **Financial Responsibilities 2019-20** form (one per family) – available during the Online Registration, in the LAM Office, and on the LAM website

___ **Getting to Know Your Student** form (one per student) – completed and printed during the online registration

___ **Emergency Consent to Transport and/or Treat My Child** form (one per student) – completed and printed during the online registration

___ **Request for Transfer of Educational Records** form (one per student entering 1st through 5th grade) – completed and printed during the online registration if required

___ **Current Immunization Records** (one per student) – Exemption Forms are available during the Online Registration, in the LAM Office, and on the LAM website

___ **Birth Certificate** (one per student)

___ **5. Schedule a Placement Evaluation** for your Student(s) with the LAM Office.

To begin the Online Registration, go to the LAM website, www.lamcda.org.

- On the left side of the screen, click on the **2019-20 NEW FAMILY REGISTRATION** link. With this link, you will register the family and one student.
- **After completing each form, click SAVE before CLOSE.**
- Complete the steps of the **NEW STUDENT APPLICATION** and the **NEW FAMILY APPLICATION**.

***NEW STUDENT APPLICATION**: Click on View Forms. Open each form and complete the fields. Please be thorough.

Student Information - All fields with an asterisk (*) are required fields and must be answered. For the student's date of birth, you can ignore the pop up calendar and manually enter the date of birth, mm/dd/yyyy. In the medical text fields, enter "none" if there are no issues.

Getting to Know Your Student** – Please complete all fields thoroughly. SAVE, PRINT, and SUBMIT to the LAM Office.

Emergency Consent to Transport and/or Treat My Child** – Please complete all fields thoroughly. SAVE, PRINT, SIGN, and SUBMIT to the LAM Office.

Release of Information Request** – Complete if your student is new to LAM and entering 1st through 5th grade. SAVE, PRINT, SIGN, and SUBMIT to the LAM Office. If your student is entering grades Kindergarten and below, click the small box at the top of the screen above the PDF document to opt-out.

****If you are unable to print your forms, please notify the office when you submit your other Registration forms and we will print it for you.**

***NEW FAMILY APPLICATION**: Click on View Forms. Open each form and complete the fields. Please be thorough.

Parent/Guardian Information for PRIMARY HOUSEHOLD – Enter parent information for the male parent and then the female parent in the Primary Household. The Full Name (P1) and Full Name (P2) are required fields and cannot be left blank. You will need to enter N/A if the field is not needed.

AUTHORIZED to Pick Up, EMERGENCY Contacts, and SECONDARY Household Information, if applicable – Please be thorough. If there are no additional contacts, or a secondary household, click the small box at the top of the screen above the PDF document to opt-out.

Household Information for Student's living in MULTIPLE HOUSEHOLDS – Describe days and hours in the Primary Home and the Secondary Home. If student lives in a SINGLE Household, click the small box at the top of the screen above the PDF document to opt-out.

Family INFORMATION - All fields with an asterisk (*) are required fields and must be answered.

***SUBMITTING YOUR ONLINE REGISTRATION**: **Submit** when the **STATUS** shows **100%** complete for the **NEW STUDENT APPLICATION** and the **NEW FAMILY APPLICATION**. If you don't see 100%, you will need to return to the form and complete all fields before it will allow you to submit.

***Registering more than one student?** After completing the **2019-20 NEW FAMILY REGISTRATION**, return to the LAM website, www.lamcda.org. On the left side of the screen, click on the **2019-20 SIBLING REGISTRATION FOR NEW FAMILIES** link. Repeat for each additional student.
